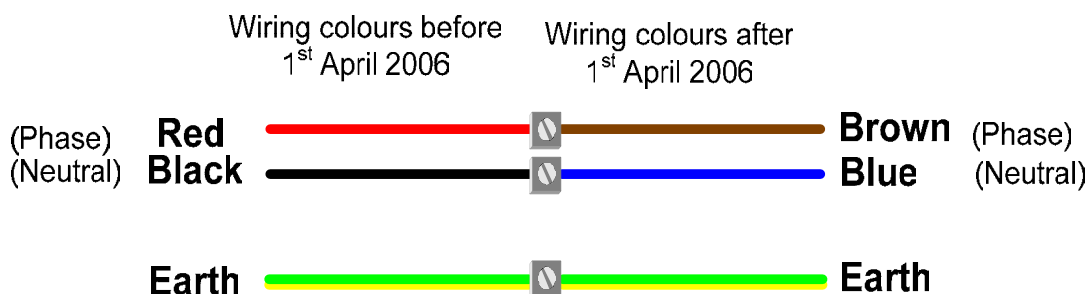


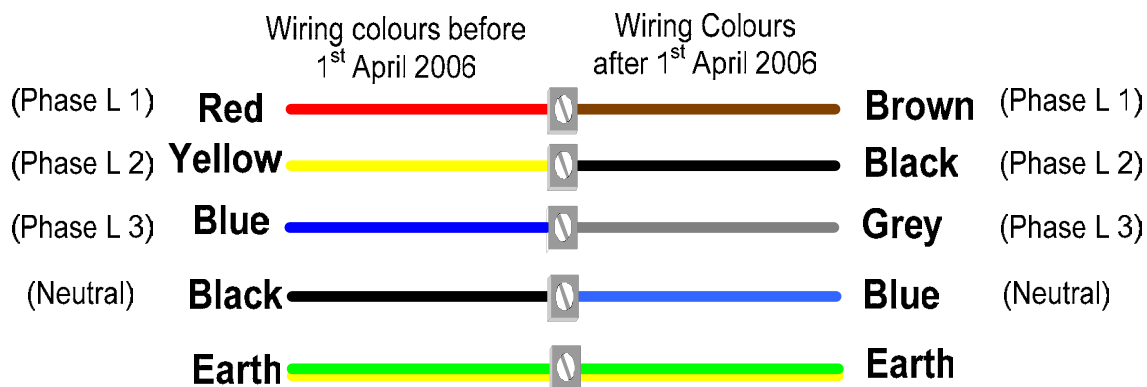
ATTENTION TO ALL WIREMEN

We wish to draw your attention to the guidelines issued by the Malta Resources Authority in 2005 and remind you that as from 1st April 2006 a new standard for wiring colours became mandatory according to Amendment 2 : 2004 to BS 7671 : 2001(I.E.E Regulations). This leaflet shows how the new wiring colours correspond to the wiring colours for single and three phase installations used before the 1st April 2006. 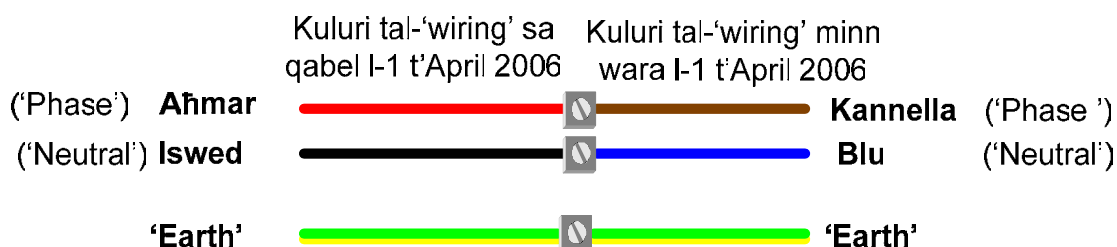

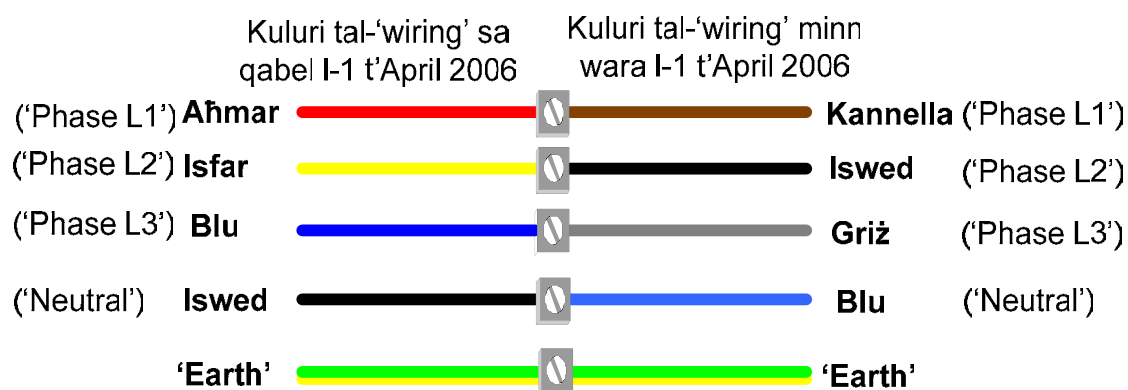
