7.(1) Any person who submits incorrect, incomplete, or false information in the application made to the Authority, shall be guilty of an offence and shall be liable to a fine (multa) of not less than nine thousand and three hundred euro (€9,300) but not exceeding eighteen thousand and six hundred euro (€18,600).

(3) Such fine shall be without prejudice to any other punishment for which that person would be liable under any

other law or regulation.
